If you are a tax payer your donation can be increased by 25%, at no extra cost to yourself by completing one of our Gift Aid declaration forms if you have not already done so. This will allow us as a charity to claim from HMRC, an amount equal to the tax paid on any donation you make to us. [Gift Aided donations can only be accepted from individuals.]

For those of you who have completed a declaration form in the past would you please ensure that you have complied with the following regulations required by HMRC, and notify us of any changes which you have not already told us of?

Please note, you must notify the charity if you:-

wish to cancel the declaration.

change your name or home address and you must include your post code.

no longer pay sufficient tax on your income and/or capital gains to cover the amount of your donations.

if your donations are being made by a couple via a bank standing order from a joint account each of you must complete a declaration form and advise the charity how much each is donating.

NB:- If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief available, you must include all your Gift Aid donations on your Self Assessment tax form.
